**I understand that there shall be no initial initiation fee due upon submission of my Application for Membership for the preview membership.** However, by electing to join as a preview Member, I agree to the following terms and conditions as they relate to joining.

1. **Commitment to membership for a minimum preview term through April 30, 2013.** I hereby obligate myself for the payment of all applicable monthly dues, fees and charges during the preview membership term, subject to the terms associated with the 2012 Preview Membership Initiative and shall conclude on April 30, 2013.
2. **Termination of privileges or membership purchase at conclusion of the preview membership term.** On May 1, 2013, my preview membership and all of my privileges thereunder shall terminate unless prior to said date I elect to do one of the following:
  - a. **On or before April 30, 2012,** pay the reduced 2012 Preview Membership Initiative initiation fee for the applicable membership category shown below. The required reduced initiation fee must be paid in full on or before April 30, 2012, in order to enjoy the reduced fee.

5. **Recallable membership.** The Club has the absolute right and discretion to recall my preview membership at any time before the membership terminates. 6. **Promise to pay applicable initiation fee.** I understand that should I exercise the initiation fee payment options as outlined in Paragraph #2, I will be obligating myself to the terms for the payment of the applicable initiation fee as represented within said paragraph.
7. **Final interpretation.** The Club reserves the right to make final decisions pertaining to all matters regarding the 2012 Preview Membership Initiative.
